### **CAL-ABOTA PRESIDENT'S REPORT**

This mid-year report will be brief. I just want to bring you up-to-date on some new developments and future initiatives.

#### **Bringing Civics Back to The Classroom**

The office of the Chief Justice of the California Supreme Court, in collaboration with State Superintendent of Schools, has initiated a program to address the issue of inadequate civic education in our public schools. A "Power of Democracy Task Force" was formed to study the problem and make recommendations. The task force issued a report entitled "Revitalizing K-12 Civic Learning In California: A Blueprint for Action" last August. Since then a number of school districts have adopted resolutions to implement the recommendations of the task force.

Earlier this year, the Chief Justice's Office, knowing that CAL-ABOTA is particularly interested in youth education, reached out to CAL-ABOTA President-Elect Michael Bradley. Mike and CAL-ABOTA Education Committee Chair, Bryan Reid, met with the Chief Justice's Senior Court Services Analyst when our Board was in San Francisco for its May meeting. Bryan and Mike intend to stay involved with this initiative by the Chief Justice which could lead to stronger contacts with educators, making ABOTA's Teacher's Law School and James Otis Programs easier to implement.

Since our May meeting, a Judge of the San Diego Superior Court contacted San Diego Chapter President Sheila Trexler and invited that chapter to participate in on-going efforts to convince various San Diego school boards to adopt a "Civics Learning Resolution", committing school districts to adding civics education to their curriculum. San Diego chapter member Stephen Grebing volunteered to serve on a working committee with school board representatives to create the new curriculum.

Rather than waiting for a new curriculum, some educators expressed an interest in using ABOTA Foundation educational materials now. Stephen, with National's help, provided those materials. We will track the San Diego chapter's progress and let you know what develops.

### **Expedited Jury Trials**

After my last report, CAL-ABOTA formed a subcommittee, chaired by Wally Yoka, to look into on-going discussions between plaintiff and defense trial lawyer organizations on making Expedited Jury Trials mandatory, at least on some level and in some form. Although CAL-ABOTA supports an extension of the current voluntary Expedited Jury Trial legislation, we will not directly participate in the on-going discussions of the joint committee. Instead we will keep track of future developments and if any draft rules or legislation is circulated for comment, we will decide at that time whether to weigh in.

### **Public Service Announcements**

Steve Glickman's Jury Service video so impressed the Judicial Council that it sought and received permission to post the CAL-ABOTA video on the Jury Service page of the Judicial Council of California website.
